Additional Information

Plan early. Transfer applicants are strongly encouraged to connect with a Texas A&M University admissions counselor as soon as an interest in Texas A&M University is identified. Early consultation with an admissions counselor can help the prospective student identify an appropriate path toward transfer admission. Admissions counselors are available in person and by telephone or email in Prospective Student Centers across the state of Texas, as well as on campus in the Aggieland Prospective Student Center.

Applicants are encouraged to use the required essay as an opportunity to identify their past accomplishments, discuss what they hope to study at Texas A&M University, and describe how their education will help them meet goals after graduation. Application essays are read and reviewed for content, presentation and style.

Mays admits 100 transfer students each year. Transfer students are admitted for summer or fall semesters only. No spring admissions. Successful applicants have required coursework complete at time of application with consistently excellent grades. Mays admits its complete transfer admission class in the original review of applications; as such, spring grades are not considered for summer or fall transfer admission decisions. Second-choice majors are not accepted.

Preference is given to applicants ready to join Mays' junior class upon arrival at Texas A&M.

Mays' undergraduate program is subject to strict enrollment management. Although no minimum GPA is required, the competitive nature of transfer admission to Mays results in denial of many highly qualified applicants.

1. MATH 2414 and 2413 are accepted in lieu of MATH 1324 and 1325, respectively.

2. Although specific grades are not required, Mays transfer admission is highly competitive. Applicants need a grade of 'A' in most courses to be competitive. Courses in progress at the time of application are considered incomplete.

3. TCCNS ENGL 1301 is accepted for TAMU ENGL 104 only if completed prior to Fall 2014.

4. Take Public Speaking in a classroom setting. Note that SPCH 1321 is NOT accepted for the SPCH 1315 requirement.

5. Many community colleges removed MGMT 211 from their course offerings. Blinn College offers BUSI 2371, which is an accepted MGMT 211 equivalent. Note that BUSI 2301 transfers to Texas A&M University as MGMT 212 and is NOT accepted for the MGMT 211 requirement.

6. Follow the Core Curriculum requirements of your Texas public institution for fulfilling these requirements: Life & Physical Sciences (9), Creative Arts Elective (3), Social & Behavioral Sciences Elective (3), and Philosophy, Culture & Language Elective (3).
