Coursework Timeline

- Competitive applicants will have all 30 credit hours of Required Coursework completed prior to the submission of a transfer application. Any in-progress coursework at the time of application **will not** be considered in the transfer admission review process.
- Follow the recommended sequencing of the 10 Required Coursework classes to avoid course pre-requisite constraints.
- BUSN 101 (BUSI 1301) is a required course in the BBA curriculum but is not on the list of 10 Required Courses for transfer admission to Mays. It is a good introduction to business and as such BUSI 1301 is appropriate to take in the first semester if available.

Additional Information

- Plan early. Transfer applicants are strongly encouraged to connect with a Texas A&M University admissions counselor as soon as an interest in Texas A&M University is identified.
- Transfer students are admitted for summer or fall semesters only. **No spring admissions.**
- Mays admits 100 transfer students each year.
- Mays admits its complete transfer admission class in the original review of applications. As such, spring grades are not considered, and Mays does not hold applications to be reviewed pending the posting of in-progress spring grades.
- Applicants need a grade of "A" in most courses to be competitive. Courses in progress at the time of application are considered incomplete.
- Personal Statement: Applicants are strongly encouraged to use the required essay as an opportunity to identify their past accomplishments, discuss what they hope to study at Texas A&M University, and describe how their undergraduate business education will help them meet goals after graduation. The most effective transfer admission essays detail the applicant's academic and career goals. Application essays are read and reviewed for content, presentation, and style. Essays are an important component of the transfer application, as the level of competitiveness continues to rise; more and more, applicants' transcripts tend to meet all requirements with excellent grades. How and what you write can distinguish you as an applicant, and this can make a difference in the admission decision.
- Although Mays does not state a specific number of Maximum Transferable Hours, acceptance of transfer credit for business courses will generally be limited to those courses taught in the freshman and sophomore years at Texas A&M University. **Mays undergraduate students must take all 300- and 400-level business coursework in residence at Texas A&M University.**
- Preference is given to applicants ready to join Mays' junior class upon arrival at Texas A&M.
- Meeting minimum requirements does not guarantee admission. The entire record is reviewed for consistency in coursework and grades. The highly competitive nature of transfer admission to Mays results in denial of many well qualified applicants.
- Mays' undergraduate program is subject to strict enrollment management.
- **IMPORTANT:** Transfer applicants are instructed **not** to accept transfer admission to a non-business major with the expectation of later applying for an on-campus change of major to Mays. Transfer students admitted to a non-business major are generally **not** eligible for future on-campus change of major into Mays Business School.

Transfer Course Sheet Notes

1. Admission preference is given to applicants with the highest GPA and the most appropriate courses completed. The entire application is considered.
2. Transfer applicants are encouraged to complete [University Core Curriculum](#) coursework found in the [Undergraduate Catalog](#) unless specified above.
