Transfer students admitted to a non-business major are not eligible for future on-campus change of major into Mays Business School.

### Coursework Timeline

- Applicants interested in studying **Accounting** or **Finance**, are highly encouraged to be freshman applicants. Taking ACCT 229 at Texas A&M is highly recommended.
- BUSN 101 (BUSI 1301) is a required course in the BBA curriculum but is not on the list of required coursework for BUAD transfer admission to Mays. Admitted BUAD transfer students will satisfy the BUSN 101-degree requirement with a course taken in residence (BUSN 403).
- **Follow the Core Curriculum requirements of your Texas public institution for fulfilling these requirements:** Communication Electives; Life and Physical Sciences Electives; Creative Arts Elective; Social and Behavioral Science Elective; and Language, Philosophy and Culture Elective.

### Additional Information

- Plan early. If interested in Texas A&M University, you are strongly encouraged to connect with our admissions counselors as early as possible.
- Transfer students are admitted for summer or fall semesters only. **No spring admissions.**
- Mays admits 100 BUAD transfer students each year.
- The total enrollment of Mays' undergraduate program is limited to a specified maximum which creates a competitive admission process.
- Applicants need a grade of "A" in most courses to be competitive.
- Applicants who show a pattern of withdrawing from and/or repeating courses, are less competitive.
- Meeting minimum requirements does not guarantee admission. The entire record is reviewed for consistency in completing all attempted coursework and grades. The highly competitive nature of transfer admission to Mays results in denial of many well qualified applicants.
- Although Mays **does not state a specific number of Maximum Transferable Hours**, acceptance of transfer credit for business courses will generally be limited to those courses taught in the freshman and sophomore years at Texas A&M University. **Mays undergraduate students must take all 300- and 400-level business coursework in residence at Texas A&M University.**
- Personal Statement: Applicants are strongly encouraged to use the required essay as an opportunity to identify their past accomplishments, discuss what they hope to study at Texas A&M University, and describe how their undergraduate business education will help them meet goals after graduation. The most effective transfer admission essays detail the applicant's academic and career goals. Application essays are read and reviewed for content, presentation, and style. Essays are an important component of the transfer application, as the level of competitiveness continues to rise; more and more, applicants' transcripts tend to meet all requirements with excellent grades. How and what you write can distinguish you as an applicant, and this can make a difference in the admission decision.
- **IMPORTANT:** Transfer applicants are instructed **not** to accept transfer admission to a non-business major with the expectation of later applying for an on-campus change of major to Mays. Transfer students admitted to a non-business major are **not** eligible for future on-campus change of major into Mays Business School.

### Degree Offerings at Mays Business School

Mays Business School offers two business degree programs: a **Bachelor of Business Administration (BBA)** and a **Bachelor of Science (BS)**. Students in a BBA program complete a set of Core Business Knowledge courses and specialize in a major to earn a degree in accounting, finance, management, management information systems, marketing, or supply chain management. Students admitted to a BBA program should expect to graduate with a Bachelor of Business Administration in (major field here).

Students in the BS program complete the same Core Business Knowledge courses as the BBA program. Instead of further specializing in one of the majors previously listed, BS students create a customized focus area of their choosing with the support of an advisor to help them realize their unique professional goals. This degree program requires the student to complete an internship. Students admitted to BUSI should expect to graduate with a Bachelor of Science in Business Administration.

Apply to **BUAD** to pursue a BBA program. Apply to **BUSI** to pursue the BS program.

### Transfer Course Sheet Notes

1. The undergraduate program at Mays Business School is enrollment managed. Admission is highly competitive. Though preference is given to applicants with the highest GPA, the entire application is considered.
